How and when the FlexForum gets visibility of progress

The FlexForum provides a framework for coordinating and collaborating on the practical steps needed to enable a household, business or community to make choices which maximise the value of their DER and flexibility...

Coordination and collaboration require visibility of activity and progress...

- At the outset. Visibility of ideas and proposed projects or activities which might inform delivering the outcomes outlined in each step of the Flexibility Plan would assist with getting the scope right, finding project partners and with avoiding duplication (or achieving alignment)
- While delivering the project or activity (not frequently, and perhaps not in exhaustive detail). Visibility of progress and emerging outcomes would provide transparency, inform the thinking of others working on similar or complementary problems and provide an opportunity to test thinking and share challenges
- At the end. Visibility of outcomes is needed to demonstrate progress, enhance trust in the process and the credibility of outcomes by enabling dots to be joined and a broader whole of supply chain view to be provided to policy makers, regulators and the electricity sector

Evie and Scott will provide a brief overview of the Resiflex project to provide a reference point for discussing a process or workflow which:

- achieves the visibility needed for coordination and collaboration
- achieves the visibility of progress needed to report progress and identify updates to the Flexibility Plan
- yet isn't burdensome

Outcome sought: an initial process and set of expectations for obtaining visibility of activity and progress

How and when the FlexForum gets visibility of progress – what this could look like...

The FlexForum has talked about setting up a knowledge hub listing demonstration projects, and eventually, the resulting insights and outcomes


- the knowledge hub would be a starting point for match-making and information sharing, along with webinars/workshops etc
- visibility of activity and progress are needed for the FlexForum to do what people would like it to do (see selected workshop comments)

What could this look like? Without the FF being seen as a gatekeeper and without requiring great effort...

- nearly all demonstration projects will be 'external' undertaken by participants and others, not the FlexForum. The FlexForum is a hub for collating and disseminating information and tracking progress
- people must want to provide general visibility of their activity/project across its life cycle and offer to include it in the knowledge hub
- the activity should be related to a step in the Flexibility Plan
- project approach should be collaborative, eg, getting input on the project scope, being open to involving partners (where relevant)
- project results and outcomes should be shared, potentially during, and at the end

A selection of comments from the workshop on supporting coordination and collaboration

- Value is getting lots of feedback in one spot from diverse parties
- Knowing who is doing what to enable more and better collaboration
- Coordinate learnings between other work programmes
- Writing up and sharing case studies and outcomes
- Taking insights and making it digestible and useable to facilitate sharing



Learning-by-doing ecosystem review – project scope, approach and resourcing

Flexibility Plan 1.0 step #B says, 'Ensure coordination between agencies and bodies with a role in supporting learning-by-doing'.

- the purpose is to identify possible improvements to the learning-by-doing ecosystem to ensure organisations attempting learning-by-doing relating to flexibility have access to appropriate and effective support for learning-by-doing
- the step was included in the plan based on several FlexForum discussions about opportunities to improve the learning-by-doing ecosystem

A Learning-by-doing ecosystem review is part of the FlexForum phase 2 work plan

- the project would provide two outputs relevant to achieving the MBIE deliverables and to current policy and regulatory considerations ,eg,
 Commerce Commission review of the Input Methodologies (specifically the innovation allowance mechanism) and Electricity Authority
 thinking about introducing a regulatory sandpit
- a FlexForum perspective on the issues with the learning-by-doing ecosystem would have wider relevance and impact and so complement the related work underway, eg, by distributors preparing advice on changes to the innovation allowance in the IMs. However,

A draft scope and approach has been shared with the group

- **Decision**: agree the scope and approach or agree to a sub-group finalising changes to address specified issues
- Decision: agree the secretariat will identify and engage appropriate resourcing

Administration: the legal entity for contracting

MBIE is finalising contractual arrangements for its financial contribution to phase 2

- the contract will be for supply of policy advice services, with four deliverables which align with the FlexForum workplan agreed at session 18 (03-11-22)
- 'Someone' needs to enter the contract with MBIE...

The FlexForum is a coalition of willing participants without formal legal standing

- it cannot open or maintain a bank account Our Energy provides this treasury function with oversight from a small group of participants
- · it cannot enter contracts to receive or provide services workarounds have been used

The contracting workarounds are not sufficient this time

• the contract deliverables rely on commitments in some form by all FlexForum participants. It is unreasonable to expect one entity to solely have the contractual obligation to deliver the FlexForum workplan

Options – 3 have been identified

- the MBIE contract could be signed by several FlexForum participants to indicate the shared commitment to delivering the workplan
- the FlexForum could establish itself as an incorporated society. The requirements are not much different to the existing terms of reference and what are likely to be included in a new charter. But it is more bureaucracy than currently in place, and will take some time
- the FlexForum could identify a host organisation prepared to hold a bank account on its behalf (and allow the FF to manage that account) and prepared to enter contracts on its behalf (raising a similar issue as currently exists)
