Learning-by-doing ecosystem

A core element of the (emerging) Flexibility Plan is a preference for learning-by-doing.

- a two-speed process would enable coordinated and collaborative learning-by-doing in the near term to develop experience and capability
- feedback loops coordinated by the FlexForum between industry, regulators and other decision-makers would enable practical experience from testing hypotheses to inform development of capability, practices and processes, and development of appropriate regulatory settings.

The learning-by-doing ecosystem for flexibility and DER includes:

- **EECA**, for example the <u>Low emissions transport fund</u> provides support to demonstrate a range of low emission technologies, services, infrastructure, innovations and business models (e.g. Mobility-as-a-Service/MaaS, transport technology and software projects), and low emission on-road vehicles. More information on support provided is available in these <u>Case studies and articles</u>
- **MBIE**, for example via the <u>Advanced Energy Technology Platform</u> and the <u>Māori and Public Housing Renewable Energy Fund</u>
- Commerce Commission via regulatory settings to enable and encourage distributors to engage in learning-by-doing
- Ara Ake which exists to support energy innovators on their journey to decarbonising Aotearoa

What extra practical support (aside from more funding) would be useful to deliver the Flexibility Plan and enhance learning-by-doing?


Flexibility Plan – proposed actions
