# 2. Procedural matters following incorporation [Policies and procedures] (1)

#### Five things that need to be decided or done

- 1. Commerce Act requirements regarding anti-competitive conduct
- 2. Policies and Procedures

#### 1. Managing Commerce Act requirements

- The Steering Group and FlexForum can operate within the requirements of the Commerce Act by taking the following steps:
  - Know your obligations you should all be familiar with the requirements of the Commerce Act 1986 prohibiting anti-competitive conduct. You should not discuss
    commercially sensitive areas of competitive activity, including (but not limited to) relating to agreements to fix, control or maintain prices, restrict output or capacity, or
    allocate markets or customers
  - Be transparent have an agenda and keep a written record of meetings/discussions
- this approach aligns with practice of other groups, eg, ERANZ working groups and has been discussed with the Commerce Commission (noting it does not give advice)

# 2. Procedural matters following incorporation [Policies and procedures] (2)

#### 2. Decision: approve the Policies and Procedures

Policies and Procedures means the policies and procedures developed by the Steering Group from time to time. The Steering Group may make, amend or rescind Policies and Procedures

The Policies and Procedures document sets out two policies that must be approved asap

- Annual subscription this policy specifies the amount of the annual subscription to be paid by Members and criteria the SG will use to reduce or waive the subscription for a Member/prospective Member. This policy must be approved before requesting Members pay the annual Membership subscription
  - SG members reviewed the draft policy in late June
  - the amounts and categories in the draft Policy have been communicated to Members leading up to incorporation
- Process for identifying and managing conflicts of interest of Steering Group members this policy describes the process for....[what it says in the *title*]. This policy must be approved because the constitution [s6.15(e)] says the SG must have a process stating how conflicts of interest are identified and mitigated
  - SG members reviewed the draft policy in late June
  - Each SG member must disclose their interests to the SG Chair. A draft Steering Group member interests register to be completed by each member was shared with the meeting materials

# 2. Procedural matters following incorporation [Subscriptions] (4)

#### 3. Decision: Approve waiving the annual subscription for University of Auckland Energy Centre, EEA and ANU BSGIP

Every Member will pay to the FlexForum an annual subscription fixed by the Steering Group. On payment of this subscription the Member will be entitled to the rights and privileges of a Member. The annual subscription will fund the functions and activities as described in the FlexForum Workplan and budget.

The amount of the annual subscription is set out in the Policies and Procedures

- \$0 for individuals who are consumers
- \$1500 for organisations with an annual turnover of \$5 million or less
- \$10,000 for organisations not in the other three categories and industry associations
- \$20,000 for the following:
  - large electricity suppliers (ie, gentailers), for example, Contact Energy, Genesis Energy, Manawa Energy, Mercury Energy, Meridian Energy and Nova Energy
  - electricity distributors with 100,000 or more individual connection points and Transpower
  - large electricity users direct connected to the transmission grid.

The subscription amount to be paid by each Member for 2023-24 is listed in the table

- requests to pay subscriptions will be sent once the bank account is open
- note: Orion Energy and Manawa Energy have pre-paid the annual subscription
- Note: subscription amounts are GST exclusive.

# 2. Procedural matters following incorporation [Subscriptions] (5)

#### Four parties have requested the annual subscription be waived/reduced

- University of Auckland Energy Centre, EEA, ANU BSGIP and Octopus Energy
- The SG may reduce or waive the annual subscription if doing so ... is beneficial to achieving the objectives and purpose of the FlexForum AND the decision would not create an unhelpful precedent AND the party offers material in-kind support
- Membership of the SG does not qualify as an in-kind contribution

#### Recommendation: approve waiving the annual subscription for UoA Energy Centre, EEA and ANU BSGIP

- UoA Energy Centre, EEA and ANU BSGIP each has committed to providing material in-kind support to assist with delivering the Flexibility Plan
- UoA and ANU BSGIP are academic institutions with significant technical expertise and research capability. Improving collaboration between industry and universities is beneficial to the FF objective and purpose
- the EEA has offered to assist a workstream (Stuart Johnston) and offered the option to use its online knowledge hub
- the scale of subscription amounts appears to have been broadly accepted by Members. Waiving/reducing subscriptions for commercial entities
  would create a precedent that adversely affects the ability of the FlexForum to fund itself and cause other Members to perceive unfair and unequal
  treatment.

#### 6. Steering Group

- 6.1 The management of the affairs of the FlexForum will be in the hands of the Steering Group, which may exercise all the powers of an incorporated society that are not required, either by this Constitution or the Act, to be exercised by the Members. The Steering Group:
  - may make, amend or rescind regulations, Policies and Procedures not inconsistent with this Constitution governing its meetings and the business of the FlexForum;
  - (b) may do anything necessary to carry out the objectives and purpose of the FlexForum;

#### 8. Finances and records

- 8.1 The Steering Group must:
  - (a) keep proper records of all Steering Group meetings and General Meetings;
  - (b) keep proper books of account and financial records of the FlexForum;
  - (c) keep all other documents and records, connected with the FlexForum;
  - (d) have control of all funds of the FlexForum and operate all bank accounts in the manner determined by the Steering Group;
  - (e) have control of the Common Seal, which may only be affixed to a document by a resolution of the Steering Group.
- 8.2 As soon as practicable following the end of each financial year the Steering Group will arrange for the preparation of a statement containing particulars of:
  - (a) the income and expenditure for that financial year; and
  - (b) the assets and liabilities of the FlexForum as at the end of that financial year.
- 8.3 The Steering Group will cause the statements referred to in clause 8.2 to be examined by a suitably qualified accountant, who is not associated with a Member. The accountant may request the production of any documents relating to the affairs of the FlexForum and will, if requested by the Steering Group, present a report to the Steering Group prior to the Annual General Meeting following the relevant financial year.

#### The critical path assessment exercise undertaken in March 2023 has been documented (see document)
