2 Bottom lines for partnering with EECA

Actions: Provide feedback on FF project term sheet by Monday 16 December 2025

Purpose of this item:

Discuss the FlexForum bottom lines for an MOU with EECA to deliver a scaled demonstration pilot

Context: the SG agreed in-principle on 28 November to partnering with EECA to deliver a scale demonstration pilot project, and agreed to commit resources to work with EECA and others to develop the project scope and approach

Since then, the following plan and approach has been developed:

- develop a term sheet setting out bottom lines for FF involvement to provide guardrails for developing the draft MOU
 - key issues were discussed on 09-12. An initial draft is <u>here</u>
- talked further with EECA on 10-12 about its expectations about various who/how/what aspects of the project. We are working to understand
 the context people need to make decisions to participate
- undertake a discovery phase to identify the roles and functions and methodology for the pilot project
 - project success is 'provide EDB asset management staff with practical and undeniable evidence that substituting 'poles and wires' investment with DF is a realistic and reliable alternative supply solution.'
 - · leading up to Christmas we want to be asking a few FF Members (ie, network operators and others) what practical and undeniable evidence looks like to them, and how it might be obtained ie, test a hypothesis
 - then in late January we will get FF Members to test the resulting project methodology and approach which would answer the hypothesis etc



Purpose of this item:

Update on progress with the workplan and other FlexForum tasks

The FlexForum workplan currently has 3 sets of activity/task

<u>Supporting learning-by-doing</u>. The expectation is FF activity supports learning-by-doing to accelerate delivery of the Flexibility Plan, and particularly focusing on activities which build confidence in flexibility and provide tangible benefits to humans.

- Flex Day produced 6 ideas, on top of 17 ideas provided as homework
 - · a mix of views on which Flex Day idea FF should focus on
- FF is working with EECA to develop the scope and approach to its scaled demonstration pilot. The output is a draft MOU by mid-February 2025
 - see item 2 for an update on the approach to develop the draft MOU and determine FF participation

<u>Updating the Flexibility Plan</u>. FF agreed to update the Flexibility Plan and include priorities, goals and timelines.

- Members have been asked to provide information independently or via mini workshops about flexibility business case questions, how these questions are answered now, and what actions could make answering easier/routine
- the results will be processed in January ahead of a full FF workshop to discuss/agree the updated Plan. This will be late February 2025

Advice to regulators. We are focusing on regulatory consultations which deal with FlexForum priorities

- Advice was provided to MBIE on its voltage limit proposals.
- Advice will be provided to the EA on its 2025-26 levy proposal and indicative work plan. The response is table stakes to talk to the EA about opportunities to get more bang for buck from its market development activity
- Under development. Advice to the Taskforce (and EA) on filling holes in the value stack. The 19 November workshop was excellent. The insights and suggestions are being synthesised ahead of a further discussion early 2025.

5 Finance update
